**Item 3. Purpose of Transaction**

The securities subject of this amended report are 1,316,305,600 common shares of stock of Energy Development Corporation (EDC). These include the 1,043,643,750 shares subject of the initial report of First Gen Corporation ("First Gen") dated April 27, 2010, as increased to 1,178,182,700 shares in an amended report dated April 27, 2011, plus additional common shares of stock of EDC which were purchased by First Gen and/or Northern Terracotta Power Corp. ("Northern Terracotta") from the market. Northern Terracotta is wholly-owned by First Gen.

First Gen and/or Northern Terracotta acquired additional EDC shares for the purpose of increasing First Gen's stake in EDC, as First Gen continues to believe in the value and prospects of EDC.

**Item 4. Interest in Securities of the Issuer**

The securities subject of this report are 1,316,305,600 common shares of stock of EDC equivalent to 7.02% of EDC's total outstanding common shares.
