**WHEREAS**, the DOE promulgated Energy Regulations 1-94 (ER 1-94) on August 1, 1994 to implement Section 5(i) of RA 7638, specifically granting financial benefits to host communities of energy resources and/or energy generating facilities equivalent to one centavo per kilowatt-hour (P 0.01/kwh) of the total electricity sales of generation facilities.

**WHEREAS**, **BARANGAY BULABOG**, being one of the host communities of Bac-Man Geothermal Inc. (BGI), receives ER 1-94 shares from BGI.

**WHEREAS**, aligned with our Comprehensive Development Plan (CDP), the **BARANGAY BULABOG** identifies the following priority programs for implementation using the available Development and Livelihood Fund (DLF) and reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF) of the barangay.






